Equities

The Nigerian Equities market suspended its bearish run, as the benchmark All Share Index appreciated by 0.78% today. Consequently, market capitalization appreciated to N21.456Tn from an opening of N21.290Tn. Market activity improved as both volume and value of trades rose by 247.40% and 16.68% respectively, to a total of 1.274Bn shares worth N6.400Bn.

February 11, 2021

The ASI was driven by appreciated in the Industrial Index (+2.57%), while four other sectoral indices closed in negative regions. The financial sector led the laggards, as the Banking Index (-2.98%) and the Insurance Index (-2.93%) recorded significant depreciations. The Oil & Gas Index fell by 0.90%, while the Consumer Goods Index inched down by 0.32%. Price appreciation in DANGCEM (+7.04%) propped the Industrial Index. On the flip side, GUARANTY (-5.12%) and ACCESS (-1.23%) depressed the Banking Index, while the Insurance Index fell as AIICO (-9.01%) and MANSARD (-3.10%) depreciated. Likewise, OANDO (-6.67%) and ARDOVA (-7.54%) pulled the Oil & Gas Index Iower, while CHAMPION (-8.94%) and INTBREW (-2.28%) overweighed the Consumer Goods Index.

Fixed Income & Money Market

Stop rates surged at the NTB Primary Auction held yesterday, settling at 1.0000%, 2.0000% and 4.0000% for the 91-Day, 182-Day and 364-Day bills respectively. Similarly, average yield rose by 32bps to 1.35% at the NTB secondary market today.


Average yield rose further in the Federal Government Bonds secondary market, appreciating by 9bps to 9.00%. Yield appreciations were recorded across the curve. Yields on the 15 July, 2021 and the 27 March, 2050 maturities rose by 62bps and 44bps respectively, to 1.50% and 10.96%. The 26 April, 2049 bond yield gained 25bps to close at 10.85%.


Currencies & FX Reserves

The Naira closed flat at \(\frac{14}{4}\)00.00/USD against the U.S Dollar in the I&E window, while gaining 0.63% to \(\frac{14}{4}\)75.00/USD in the parallel market. The SMIS and official exchange rates closed flat at \(\frac{14}{4}\)380.69/USD and \(\frac{14}{4}\)379.00/USD respectively.
